**Minutes:** Jim Rancilio moved to approve the minutes from the October 10, 2007

meeting. Nanette Ricker seconded the motion. Motion carried.

**Director's Report:** Bryon Sitler reported that:

White Pine will act as the purchasing agent for 13 libraries participating in the Gates Grant. Computers will be ordered as soon as the money is received from the Library of Michigan Foundation.

White Pine's audit was performed on November 6, 2007. The audit report will be presented to the board at its January meeting.

## Report on the Cooperative Remix Committee: Stephanie Olson reported that:

The committee was looking at 3 models.

More than likely only the strongest Cooperatives will survive the remix.

It is anticipated that State aid will be used to fund Mel Cat.

Legislation will be required to change the law.

No decision was made about boundaries.

There was no discussion about a transitional period.

Libraries will not need to belong to a Cooperative.

Libraries will join voluntarily.

PA 89 will need to be changed.

MLA's bylaws will need to be changed and voted on. It is hoped that the changes will be supported by a member vote in January, a board vote in May and then go into effect in July 2008.
