Director's Report: Bryon Sitler reported that:

- He visited Port Austin's new construction. It is a beautiful addition.
- Several more libraries have signed up for Health Insurance through the Cooperative. He is waiting on more information from Fosters, Collins and Smith concerning the Affordable Care Act to see what it will mean for libraries.
- The Personal Property Tax bill has passed. They are still working on clean up legislation.

- The 2012 Audit has been completed and will be presented to the board in the afternoon.

Privacy Act Revisions and Surveillance Tapes: A few members reported that they had cameras in their libraries. Locations and usage were discussed. Currently, libraries cannot break patron confidentiality by turning over the tapes to the police. A court order is needed for a library to turn over the tape for identification purposes. Libraries can however, report a crime without identifying the person. It is unclear at this time if this will be revised. MLA has not taken up this cause as of now.

Includes over 8 million songs. Currently 3600 libraries subscribe. Patrons have access to the database through the library. Music can be downloaded to ipods, mp3 players, streaming available for 45 second trial. Pricing based on population served and circulation. Statistics available.

Freading: Books.

25,000 children's and adult books available. Library pays small fee every time book is checked out. Average cost per book is .85 cents. Checkout time 2 weeks and then expires. Renewals are free. There are no platform fees.

Rocket Languages:

Is a language learning database. Includes 13 languages. American sign language is included.

Library Ideas is willing to give the Cooperative discount pricing and a free trial subscription for these databases.
