The House HAL Subcommittee is meeting 3/14/07. All of the subcommittees are to report their budget recommendations to the full Appropriations Committees this week.

The Cooperative Directors' Association appointed a committee to investigate the future of cooperatives. I am the Chair of the group and have been doing research on what our future could be. So far, we have only had e-mail discussions, but will meet as a group later in the month. Nancy Robertson will also meet with us so that we are all working towards the same goals.
