## WHITE PINE LIBRARY COOPERATIVE BOARD MEETING MINUTES

## **August 13, 2008**

A regular meeting of the White Pine Library Cooperative Board was held on August 13, 2008 at the White Pine Library Cooperative Headquarters.

- 1. **Call to Order:** Board Chair, Mimi Herrington called the meeting to order at 1:50 pm.
- 2. **Approval of Agenda:** Bryon Sitler asked that Peck Community Schools be added to the Agenda. Rose Rice Gutierrez moved to approve the agenda with the addition of Peck Community Schools. Jim Rancilio seconded the motion. Motion carried.
- 3. **Minutes:** Rose Rice Gutierrez moved to approve the July 9, 2008 minutes. Tari Dusek seconded the motion. Motion carried.

- 6. **Technology Grant:** The board discussed creating a grant that would help the non-automated libraries get automated. There was no decision made at this time.
- 7. **Plan of Service Committee:** Rose Rice Gutierrez, Stephanie Olson and Mimi Herrington will work on next year's plan of service. Bryon will send the committee the draft plan of service and by-laws.
- 8. **Nominating Committee:** Mimi Herrington, Teri Dusek and Jim Rancilio were appointed to recommend a proposed slate of officers for next year.
