Board report September, 2011

State Aid was finalized at \$.22 per capita.

Kathy tells me she has finalized the second payments now and they should be ready soon.

New Board members have been found to fill vacant positions. There were 5 vacancies.

OverDrive is growing – 22 libraries now participate. I am ordering the e-books. If you are interested in joining, October 1 is the next opportunity. After that it will be January 1, 2012.

Health insurance is in place. Two libraries are using the service.

The Court of Appeals rendered its written opinion August 17 in favor of Herrick District Library. It was very strongly worded so I hope LM does not choose to appeal to the Supreme Court. It has 42 days from the date of the opinion to request that the SC accept the case for review.

Because of population changes, legislative districts also change. I have been working on re-matching libraries with their legislators. Also because of the population, and therefore library class size, my statics sheets had to be refigured in order for the averages to be correct.

The Michigan Historical Museum in Lansing will begin charging an entry fee starting October 1, 2011.

HB 4932 was introduced 9/13 to change the population requirement to 600,000 for designation as a cooperative for an existing library system (Detroit).

Working on a "dashboard" for the Cooperatives in Michigan. Each Director was assigned a section of the re-inventing cooperatives for the future.
